**Notification of Distribution Sources
Pursuant to Rule 19a-1 under the Investment Company Act of 1940**

As noted in the table below, NexPoint Strategic Opportunities Fund (the “Fund”) is making a distribution payable on May 31, 2018, a portion of which is estimated to be in excess of the Fund’s current and accumulated undistributed net income. As of May 31, 2018, the estimated sources of this distribution were as follows:
